Item 2 – Board Notes & Action Tracker

Meeting notes from NWCHD Network Board meeting on 27th April 2022 were circulated prior to the meeting. No comments or amendments required, and all agreed an accurate record.

<u>Action 33</u> – Network MOU – IoM and Wales still outstanding. MOU to be reviewed with new Network Manager, Nicola Marpole and sent out to all NW organisations. - **IN PROGRESS.**

<u>Action 36</u> – Network Operational Delivery Group – New Network Manager, Nicola Marpole to review the membership of this group and its agenda. – **IN PROGRESS**

<u>Action 37</u> – Cardiac Maternity Guidelines & Referral Pathways – Nicola Marpole to meet in the new year with Maternal Medicines Manager/LG/SV & Lead Midwife. – **IN PROGRESS**

Item 3 – Network Update & Finances

Network Update - GG welcomed new Network Manager, Nicola Marpole to the team, who is covering for Helen Sanderson whilst on maternity leave.

Finance Update – GG reported there are no Network finance issues.

Item 4 - Regional Updates including Data

Caroline Jones, Clinical Lead & Consultant Fetal & Paediatric Cardiologist Paediatrics - Alder Hey Children's Hospital:

- In-patient workload under control post COVID.
- Waiting lists remain low for surgery and intervention, however surgery has peaked slightly in previous few months due to an increase in emergency neonatal surgery.
- EP data was missing for July & August, but this has been rectified and is still around 20 on the waiting list.
- New patients' referrals waiting list initiative clinics have been running. Capacity released with new PECSIGs attending Alder Hey clinics to see new patients.
 Spikes relate to waiting list initiative work



- Follow up Appointments excellent progress over first half of the year. However, this seems to have plateaued. A lot of the patients who are more than 12 months overdue are patients sitting in the inherited cardiac conditions clinic and are on normal follow up cycles of somewhere between three and five years. There is a good prioritisation process in place for patients.
- Appointed a new Locum Cardiologist, Dr Barbara Cardoso, who started last month and has an interest in heart failure and has done transplant work previously. She is working in the ICC clinic at both Manchester and Liverpool.
- Transition steady stream of patients coming through transition hand over clinic run jointly with LHCH. Agreed further help to understand the transition data would be helpful going forward.
 - **ACTION:** NM & LG to meet with Emma Powell, Regional Nurse Advisor for Young People's Healthcare Transition.
- New referrals remains steady sometimes up to 250 per month.
- DNA rates at AH remain steady between 6%-7%. Not unusual to see a rise during the summer school holidays.

Rachael Barber, Consultant Paediatric Intensivist/Deputy Medical Director/RMCH Paediatric Clinical Lead, Manchester University NHS FT – Gordon Gladman gave an update on Rachael's behalf:

- New patient back-logs: waiting list initiatives coincide and reflect the data
- Follow-up backlogs: slightly improved following earlier peak of COVID. Team working together to keep at a level status.
- Transition trend is steady. Many young people have video consultation clinics but this is not the hand over clinic data
- DNA rates currently between 6% & 18% the trend is improving.

Reza Ashrafi, ACHD Consultant Cardiologist, Liverpool Heart & Chest NHS Foundation NHS

- Waiting lists static. Not a lot of change to the numbers waiting and lists under control. Surgical lists have gradually decreased from previous high points.
- Backlogs follow up patients capacity issues with only two rooms available in LHCH. Numbers of patients in ACHD service continue to increase year on year as expected. The numbers are also increased as needing to see patients from Blackpool – although this only contributes a small number.
- Overall DNA rate are around 10% and new referrals are static.

Data issues remain and BC has discussed these issues with Elliott Shuttleworth,
 Divisional Director for Cardiac. LG & NM from the Network will be meeting with him on 23rd November.



- September's data to be sent through next week.
- Staff updates:-
 - Consultant, Paul Atkinson based at North Manchester retired at the beginning of October
 - Matt Daniels has now left to work in the USA
 - Julia Jones from LHCH has now started and is also doing some clinics at Manchester
 - > Dr Omar Asghar, Imaging Consultant, has joined the team for a year
- Discussions on going about the need to increase clinic capacity at Manchester

Item 5 - Cardiac Maternity Update

Sarah Vause, Consultant Obstetrician in Fetal and Maternal Medicine and Medical Director of Saint Mary's Hospital:

- The new EPR system is proving very positive, giving much greater visibility of records from medical specialities and will eventually link to GM care records. A facility is also available to record advice provided either in clinic or via a telephone conversation. MDTs are also recorded.
- Patients also now have access to significant parts of their record.
- NW Maternal Medicine Network now up and running and the Leadership team in place. The Board being reconfigured from the original shadow Board. Lead midwife appointed but not yet started hopefully January 2023.
- MDTs going well with more members across the North West joining virtually.
- Staff update: Three formally trained maternal medicine physicians have joined the team at St Mary's Oxford Road and a trainee has joined the team in Liverpool.
- Patient Information Day following the talk at the Information Day concerns
 were raised around further information being available on pregnancy and
 contraception for concerned teenage girls and their mothers. LG mentioned the
 upcoming Transition Clinics and invited SV to come along to talk to the teenagers
 including Fontan patients.

ACTION: SV & LG to work on some material for the Network website. SV agreed to attend the next Transition clinic in November.

Item 6 – Level 3 Centres Update

Matthew Sandman, Consultant Paediatrician, Ysbyty Glan Clwyd Hospital:

- Locally, clinics getting back on track.
- Clinics variable across the region depending on PECSIGs in place.

GG commented this a fair reflection across the region. Not all hospitals across the region have PECSIG representation. No incidents to report.



Item 7 – Paediatric Cardiology Partnership Group update

- Both Alder Hey & Manchester groups continue to meet monthly, and the Operational Group meet fortnightly.
- Submitted a bid to commissioners for support for next steps, awaiting feedback.
- Meeting to be arranged with the Executives Teams of Alder Hey and Manchester to decide next steps if the bid is not successful.
- Starting to develop pathways. Historically sonographers at Manchester have previously been provided by the adult service. A proposal is being written to ensure collaboration between paediatric sonography teams at Alder and Manchester Children's going forward.
- Concern raised that, resources are very stretched and will require investment to implement major transformational changes such as the single service.
- Most recent adverts have been advertised as joint site working which is more attractive to future candidates.
- Big challenges due to the lack of a consistent commissioner voice. Concerns
 raised regarding the constant changes within the commissioning team and the
 impact of that on getting decisions made. Commissioners need to be involved in
 the big decisions and discussions that need to take place. There is a lack of
 nurses and physiologists available which impacts on the ability to provide basic
 outpatient care.
- Suggestion raised to invite Michael Gregory, Regional Medical Director, North West, to a future meeting. Michael Gregory attends the ACHD Partnership meetings. RB suggested bringing him up to speed before inviting him to this board.

ACTION: RB to meet with MG prior to inviting to the NW CHD Network Board

Item 8 - Single ACHD/PTL Update

Update provided:-

- Discussions are still on-going between commissioners and clinicians regarding the drive towards a single PTL (Patient Treatment List).
- Following the meeting organised by Jalibani Ndebele (commissioner), it was agreed to postpone the paediatric PTL. Commissioners are still keen to go ahead with the ACHD PTL.
- Clarity is still required regarding how the list will function. Is it just a list of patients and who is responsible for their care and where do they receive their follow up or is it a managed PTL.



- Questions regarding who would host the PTL and who would be responsible for it.
- Helen Chadwick has taken over as our lead commissioner and will be able to provide an update at our next Board meeting.

Points raised from board members discussions:

- If the PTL is just a list of patients in our region isn't this the same as having a database?
- A database already exists at Alder Hey. Therefore, why is it necessary to pay £100k on a database that already exists?
- Previous work done by database Task and Finish Group for the Network carried out options appraisals on current databases at both LHCH and Alder Hey. It was felt that a new build was preferred for the future resilience and options to build upon.
- Current database at Alder Hey currently on AH risk register as needing to be updated.

Item 9 - Commissioner Update

New NHSE Commissioner, Helen Chadwick, could not attend the meeting today. GG presented Helen's slides, which will be circulated to Board members.

ACTION: JM to forward HC's slides.

GG confirmed the Network are due to meet with Helen shortly to bring her up to speed with Network business and will report back at the next board meeting.

Item 10 – PPV Representatives

Janet Rathburn, Chair, Patient Public Voice Group (PPV)

- Great to have Linda back and looking forward to meeting new Network Manager, Nicola at our next PPV Group meeting.
- Information Day on 15th October went very well, thank you to everyone who gave up their Saturday to attend and especially to Linda for all her help with the organisation. The feedback has been very positive with requests for it to be an annual event.
- Transition very much important issue to the PPV group and we understand the issues especially regarding resources, however, the group are keen to work with the Network to make this experience better for everyone.



Lowri Smith, Member, Patient Public Group (PPV)

 ACHD appointments – the group are concerned that some patients are turning up for appointments only to be turned away due to no Consultant available to run the clinic. Two examples raised where Liverpool and Manchester.

LG clarified one of the incidents raised was linked to a clinic at Manchester Royal Infirmary and was a hybrid clinic, a consultant was on a phased return and patients were attending for Echos and ECGs and the expecting a phone consultation a week later. LG understands that these clinics have now returned to face to face.

The second incident at Liverpool Heart & Chest hospital was something out of their control when, we understand how difficult it is for patients when a consultant is ill or is called away for an emergency.

LG also commented that as a PPV group we are trying to encourage patients that do experience a bad situation to go through the formal PALS path in order to understand the problem and learn going forward. As a group, it is learning how to encourage patients to feedback and go through the formal channels.

Going forward as a Network, we will be asking providers to report on complaints through PALS i.e. what have the complaints been about? How many have they had in relation to CHD, which will help us begin to address the issues.

Discussed this action with Governance Lead for Network. Agreed that action should be closed.
